

Minutes of Meeting Regarding Awareness Activities 2023

Proceedings:

The meeting was held in the conference room of A&P Wing NAB Rawalpindi on 10.05.2023 at 10:30 hours. Director (A&P) welcomed the participants. The meeting started with the recitation from Holy Quran. Director (A&P) elaborated the purpose of the meeting and stated that NAB being apex anti-corruption organization in the country is mandated under Section 33-C of National Accountability Ordinance, 1999 to initiate various awareness activities and to sensitize the masses on ill effects of corruption and corruption practices and join hand in the elimination of corruption from society. Director NAB Rawalpindi, welcomed the participants for joining hand in this noble cause and shared that NAB desires involvement of academics and youth, especially the students and the faculty to create awareness against this evil. During the meeting following points were discussed:

Formation and Update of Character Building Societies (CBS)

NAB Rawalpindi has already written letters to the education departments and their authorities regarding formation of CBS and updating of existing CBS and sharing the databases with NAB Rawalpindi. The participants agreed to expedite the process of formation and update of the CBS.

b. Awareness Activities:

i. Essay Writing / Painting / Speech Competitions:

Director A&P suggested that this activity may be conducted in both English and Urdu languages. For ease; Elementary and Secondary level groups be introduced to facilitate the level of competition at school and college levels. It was also discussed that the education authorities will engage schools and colleges to initiate these activities. NAB Officers may also attend some events upon receiving of invitation. The participants also agreed to hold competition at Tehsil levels at first stage and later finals will be held at District levels. The authorities/ educational institutions will intimate the results of various competitions held before 30th October, 2023. And thereafter NAB Rawalpindi will hold a grand final among the winning participants from Attock, Chakwal, Jhelum, Rawalpindi/ Islamabad. The final winners will be awarded Certificates and Cash Prizes on the eve of International Anticorruption 9th December, Day 2023. The topics for holding final competitions will be intimated well in time for ease of participants. The time limits for final competitions will also be intimated through written letters.

ii. Lectures:

Director (A&P) suggested that the seminars on anti-corruption may be conducted at various schools/ colleges of Islamabad and Rawalpindi Division. NAB Officer may also be invited to deliver lectures/ talks. The summer vacations period may also be utilized for holding seminars for teachers/ faculty.

iii. Area Branding / Display of Banners/ Standees etc.

Director (A&P) suggested that various anti-corruption slogans to be used for display of banners / standees. It was proposed that educational authorities will display in schools/ colleges with the anti-corruption slogans/ banners and paintings to sensitize their youth and to make them aware about the evil of corruption.

iv. Anti-Corruption Walks:

Director (A&P) proposed that various anti-corruption walks be conducted on regular basis. The students and faculty can carry banners with Anti-Corruption slogans as well as to sensitize their youth and to make them aware of the evil of corruption. The participants agreed to the awareness activity.

v. Anti-Corruption Wall Paintings:

Director (A&P) proposed that talents of the students can be utilized to paint the walls of educational institutions / schools/ colleges to make the masses aware about the menace of corruption. The participants appreciated the proposal agreed with it.

vi. Message of the Day: .

Addl. Director (A&P) proposed that with start of every day at educational institutions the patron in chief of CBS or its members may engage into delivering any good message to the students during the morning assembly. The participants agreed with the proposal.

vii. Awareness through Sports:

Director (A&P) also proposed that educational institutes are to be engaged for participating in sports events to create awareness. The schools and colleges of far flung areas are to be engaged where public can also participate and engage in such awareness activities. The participant also agreed to explore this area for holding such Sports Competitions.

Conclusion:

The meeting was ended with vote of thanks and decided to take action on above points in letter and spirit. The participants agreed to share their proposed schedules of activities before June keeping in view the summer vacations. The participants also agreed to share progress with NAB Rawalpindi on regular basis.
