**Subject: Compliance with NCC Directives on Textbooks and Curriculum**

In pursuance to Ministry of Federal Education and Professional Training Office Order No. F.1-1/2024-NCC Dated 4th November 2024 and in pursuance of powers conferred to Islamabad Capital Territory – Private Educational Institutions Regulatory Authority vide Section 4(a) read with Section 4(g) of ICT-PEIRA Act, 2013, printing, publication, distribution and teaching of the book titled "**Urdu (O Level, Syllabus-B)**", authored by **Shazia Islam and published by 92 Publishing House, Lahore**, stand banned in the territorial jurisdiction of Islamabad Capital Territory, with immediate effect. Copy of Officer Order is enclosed herewith for strict compliance.

2. Furthermore, in pursuance to above referred Office Order, management of All Private Educational Institutions within the jurisdiction of the Islamabad Capital Territory are instructed to ensure that no book is being taught in any class without prior clearance through a No Objection Certificate (NOC) issued by the National Curriculum Council.
3. Non-compliance to these orders, if any, shall be proceeded against under relevant provisions of ICT-PEIRA Act, 2013.
4. This issues with approval of the Chairperson (ICT-PEIRA).



**OFFICE ORDER**

In exercise of the powers conferred under Section 3(2)(c) of the Federal Supervision of Curricula, Textbooks and Maintenance of Standards of Education Act, 1976, the Competent Authority is pleased to issue an order to ban the book titled *Urdu (O Level, Syllabus-B)*, authored by Shazia Islam and published by 92 Publishing House, Lahore, in all private educational institutions within the jurisdiction of ICT, as it has been found to contain biased/derogatory/sub-standard content on pages no 372-373.

2. The Chairperson of ICT-PEIRA is further requested to instruct all private educational institutions that no book shall be prescribed for any class without an No Objection Certificate issued by National Curriculum Council (NCC) Ministry of Federal Education and Professional Training, Islamabad.
