
On February 6 2023, a magnitude 7.8 earthquake struck the Gaziantep region in Turkey and Northwest Syria killing more than 10000 people. Thousands are injured and infrastructure has also been damaged while the coldest month of the year, vulnerable children and families are now left out in the freezing cold. As a result of huge earthquake, large area of both countries are still under risk due to shelter and food. They need our help at this point of time to cope with the quake caused destruction as well as homeless.

2. Therefore, it is our prime responsibility to support and contribute in relief process and extend maximum support to both the brother Countries i.e Turkiye and Syria and the peoples specially, in line with the commitment of Government of Pakistan. In this connection, the most effective way we can donate is by making contributions in terms of money for ongoing post-earthquake relief operations. - Every child/ student shall contribute whatever they can.
- A camp outside main entrance of school shall be established to collect donations from visitors and parents. A responsible staff member shall be deputed for safety and collection of donation in the camp.
- Only Cash shall be collected and receipt of cash must be issued
